



## THE CALVARY OF BENEDICT XVI NON PRAEVALEBUNT (1)

**B**EHIND HIS RAY-BAN, THE DESK IN A LAW FIRM AS A COVER, A LIKABLE JEW AMERICAN WAS PREDICTING BY MANY MONTHS THAT HE WOULD HAVE FORCED BENEDICT TO RESIGN.

He is tied hand in glove with a skilled journalist who can penetrate the secrets of the Vatican and today he might assume to have reached his goal. After the death of a pope another one is made, the Romans say, however, since time immemorial. Apart from certain formal details, between death and abdication (this is what it is, not "stepping down") there is no big difference. Pope Benedict, in anticipation of the conclave, breaks the tight encirclement where he is surrounded even by those who should have been protecting him.

The prophecies about his resignation, circulated in 2012, also in Jewish circles which favor Benedict XVI, have an explanation. When he went as a pilgrim to the Holy Land in 2009, the Israeli intelligence stole a little of his urine (as they do often with distinguished visitors). After analyzing them, they forecasted "four years of life" for the Pope. It was May of 2009, the four years of Israeli prognosis expire in less than three months. The pope has a severe and painful degenerative hypertrophic cardiomyopathy. His heart beats a lot and pumps very little. Add the advanced age and other vascular disorders, exacerbated by the desk, and you can understand that the ability to survive for long is unlikely; even less than likely - and this is the greatest danger - is the possibility of him being lucid to the last. This clinical picture, says a cardiologist, can be cured with surgery. Sure, but not when you do chemotherapy three times a week because of a leukemia.

BXVI, aware of his condition, by abdicating has avoided two dangers looming: offering the right to speculation about his disappearance and, worse, end up under the control of others, when his mental faculties were attacked by the disease.

The vatileaks and the artful diffusion of the document in German (published exactly in these days of 2012, announced his death within one year, exactly at the expiration of the Israeli prognosis), gave BXVI the assurance that the tentacles of Chicago circles

were stirring, the most hostile to the Catholic Church, determined to oppose the universal mission of the pope; the founding goal of satanic circles, spiritual heirs of Saul Alinsky, inspiring even Barak Hussein Obama.

The design behind the screen of the letter announcing the attack on the Pope was clear: whatever illness killed BXVI, his death would be attributed to a murderous hand inside the Vatican and, thus, would be restarted against the sacred walls the fan with manure, in order to discredit even more the tenants. A script adapted from the one already seen in the attack on John Paul II.
